Epistemology

Episteme – knowledge; understanding

Epistemology - the study of knowledge; how do we know things? What do we know?

What is a proposition?

A proposition is a sentence which can either be true or false.

	Proposition?
The sky is blue. subject predicate	Yes
Zaid is not eating. subject predicate	Yes
Stand up!	No

So, in a proposition, you either affirm or negate the predicate of the subject.
Another term for a proposition is judgment.

What is truth?

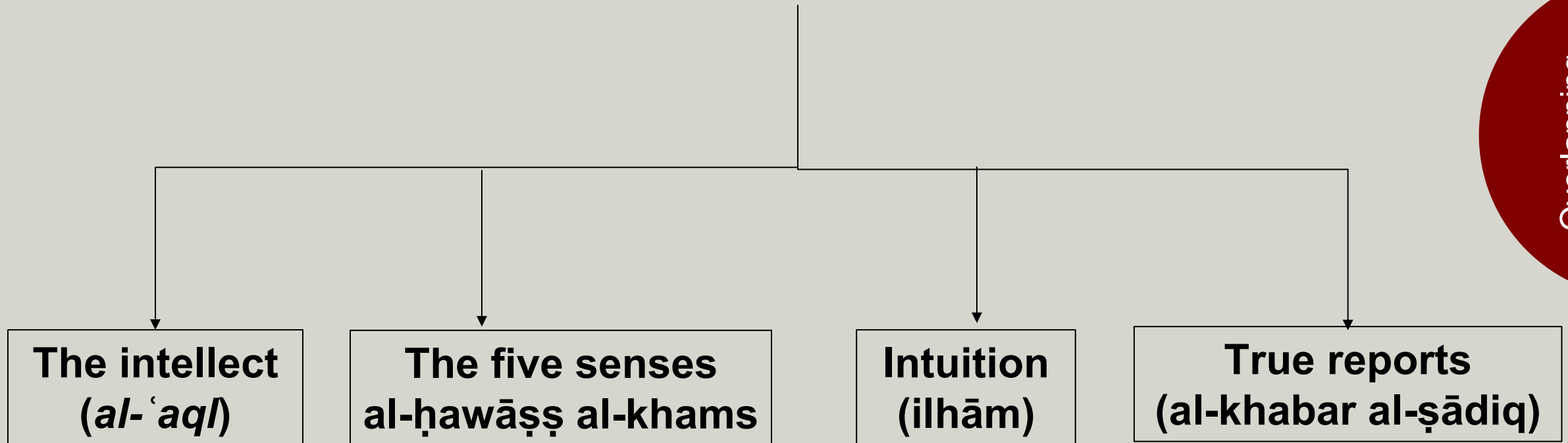
We stated that only propositions, or judgments, can be true or false.
Yet, the question remains: *how do we know if a proposition is true or not?*

For a proposition to be true, it must *correspond* to the object as it truly is.

This is known as the
correspondence theory of truth.

Epistemology

Muslim theologians state that humans have the following sources of knowledge:

Epistemology – the senses

The **five senses**: touch, sight, hearing, taste, and smell.

The five senses provide us knowledge of physical objects.

Scholars call this knowledge ***empirical knowledge*** (knowledge from the senses).

Epistemology – the intellect (*al-‘aql*)

First principles of thought:

- Principle of non-contradiction (PNC)

Statement A : *Two is an even number.*

Statement B : *Two is not an even number.*

According to PNC, statement A *and* statement B cannot be true.

Epistemology – the intellect (*al-‘aql*)

First principles of thought:

- Principle of excluded middle (PEM)

Statement A : *Two is an even number.*

According to PEM, statement A is either true or false.
There is no middle state between true and false.

Epistemology – true reports

Knowledge gained from true reports (*al-khabar al-al-ṣādiq*) refers to knowledge we gain based on the testimony of others.

Testimonial knowledge rests on the *reliability* of the person conveying the Knowledge.

Can you provide me with examples of knowledge we gain from true reports?

Epistemology – Intuition

ilhām is divine inspiration that Allah Almighty reveals directly to a person's heart.

For example: Dreams

- Umar R – warning the Muslim army from afar.
- Fredrick Kekule – discovering the chemical formula of benzene

For all knowledge, make it a habit of thinking about what kind of knowledge it is and verify its level of truth.

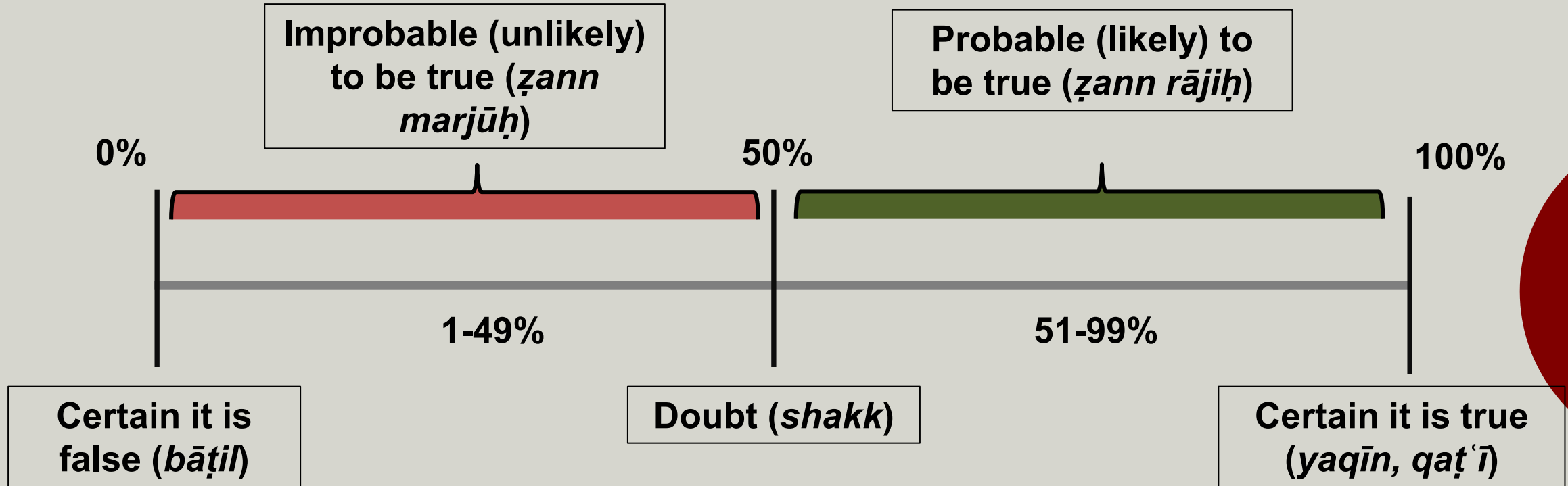

“And [for] their saying, ‘Indeed, we have killed the Messiah, Jesus the son of Mary, the messenger of Allāh.’ And they did not kill him, nor did they crucify him; but [another] was made to resemble him to them. And indeed, those who differ over it are in **doubt** about it. They have no **knowledge** of it except the following of **assumption**. And they did not kill him, for **certain**.”

(Sūrah al-Nisā’ 4:157)

self-evident: judgments which *do not* require thought

inferential: judgments which require thought

Judgments

Three types
of judgments

→ Revelatory judgments – these are statements that are only known from Allah, the Exalted and His messenger. Examples: fasting during Ramadan is an obligation.

self-evident: the five pillars of Islam

inferential: there is no zakat on diamonds

→ Rational judgments – these are statements we know which do *not* require our senses nor revelation. Examples: 1 plus 1 is 2, 7 is not an even number.

self-evident: 1 is half of 2

inferential: 40 divided by 4 divided by 10 is 1

→ Empirical judgments – these are statements we know only from our five senses. Examples: fire burns, the speed of light is 299,792,458 m/s.

self-evident: fire burns

inferential: pepto bismol treats indigestion

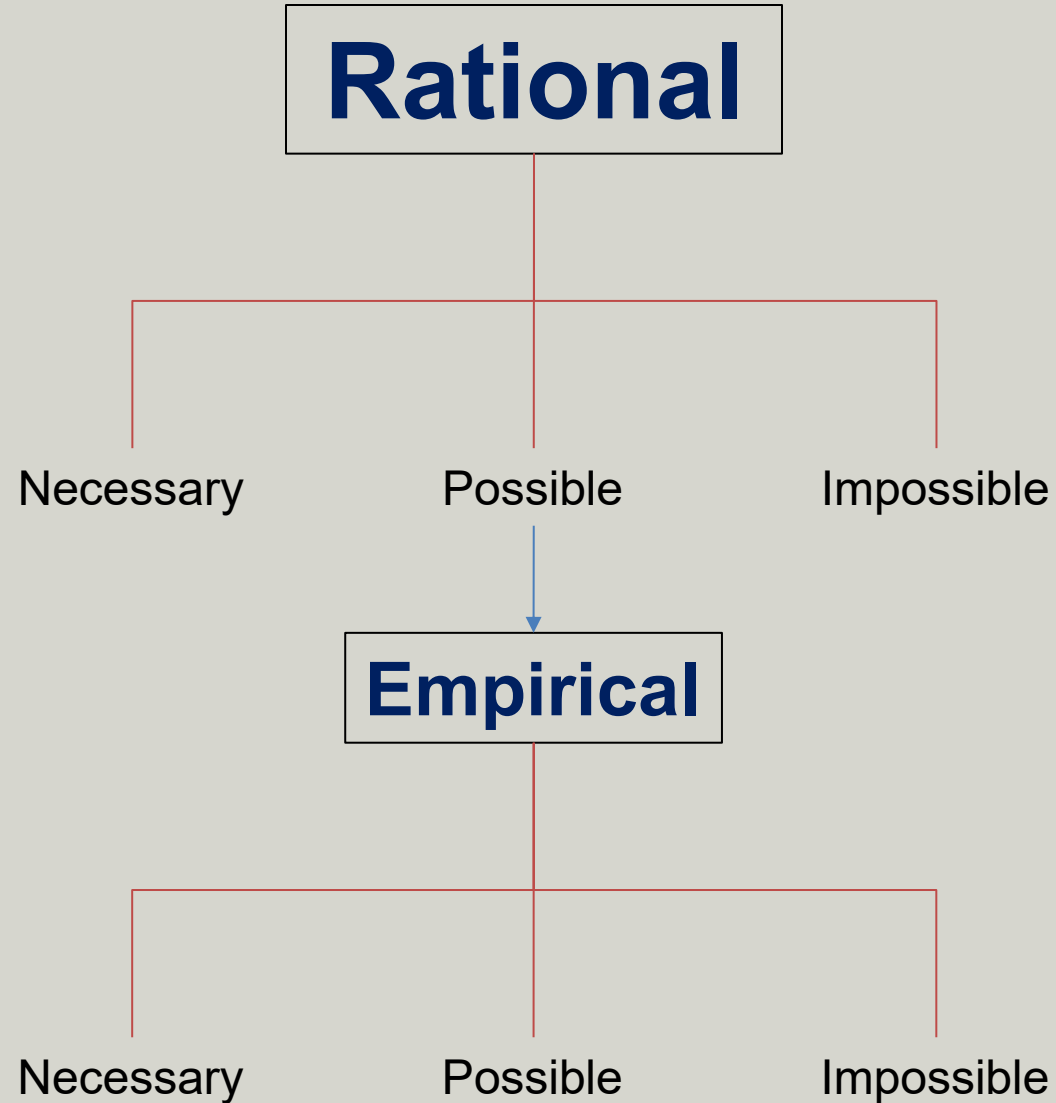

Answer

All empirical judgments can *only* fall under *possible* rational judgments.

The Level of Certainty of Judgments

Conclusive – qaṭʿī

e.g., a proposition we *are absolutely certain* of or a text that does not admit of more than one meaning

Probabilistic – ḡannī

e.g., a proposition we *are not certain* of or a text that does admit to more than one meaning

Naturalism

- The belief that everything arises from natural properties or causes
- Science is the study of natural properties and causes
- Therefore, science can discover everything

A philosophical school which maintains “that reality is exhausted by nature, containing nothing “supernatural,” and that the scientific method should be used to investigate all areas of reality, including the “human spirit” (Stanford Encyclopedia of Philosophy)

Karl Popper—Science is the only way to the truth

Falsification Principle

- A scientist's job is to be critical of any, and all, claims.
- A scientist should set out to disprove a hypothesis.
- Only deduction can be used

Issues of Popper's falsification principle

- We must use induction due to limited observations
- Must agree on accepted principles
- Limited to observational/empirical data only (ignores rational and revelatory judgments)
- Popper never believed in attaining certainty, so even science is not a way to certainty

Anthony Flew—His own words can be used to refute his argument.

Verification Principle

Verification Principle

- A scientist's job is to empirically prove any, and all, claims.
- A scientist should set out to disprove a hypothesis.
- Aimed to eliminate metaphysical and speculative assertions that could not be tested through empirical observation or logical analysis.

Issues with the verification principle

- Excludes many statements that are considered scientifically meaningful but are not directly verifiable (e.g., universal statements)
- Limited to observational/empirical data only (ignores rational and revelatory judgments)
